Style of Work

- 1 Priorities of DBI are chosen according to 2 priorities:
 - Expertise of Salesians in the field.
- Relevant in the current political context.
- 2 DBI tries to involve the Provinces and Salesian NGOs when:
 - We offer a concrete oportunity: event, document or contact that is useful to the daily work of the Salesian entity.
 - We contact the Province using always the INSTITUTIONAL channels: Provincial and any other
- relevant stakeholders (via Youth Ministry Councillor).
- We support the participants when reaching Brussels.
- We try to give voice both to the professionals and young people coming from the Salesian LOCAL reality.
- 3 DBI takes part in alliances and institutional meetings according to these priorities with the aim of:
 - Sharing Salesian Best Practices on that topic.
 - Knowing the field of each topic so to identify concrete opportunities for Salesians.



STRATEGIC PLAN 2015-2017

Our Strategic Plan from 2015 to 2017 consisted on three thematic priorities:





Migration and Refugees.







Develop through three action lines:

- 1 Identify the strengths and potentialities of SDB works in Europe (and cooperate with them).
- 2 Identify the most interesting places to advocate for each
- priority (and offer them to our Salesian realities).
- 3 Coordinate participation of Salesian intervention in EU institution

In addition, there was a transversal priority of institutional reinforcement, to adapt Don Bosco International to the new needs of the Salesian Congregation.

- Set up channels of communication that bridge the gap between local SDB realities and EU
- Develop joint projects or activities of advocacy
- together with other Salesian networks (DBYN, DBN, New York, SF)
- Promote internal reflection within Working Groups and set up policy papers

But we have enriched approach with three different frameworks:

Convention on the Rights of the Child: The Convention changed the way children are viewed and treated. as human beings with a distinct set of rights. Within the Salesian tradition, there is a clear commitment to see children and youth as subjects rights therefore, many Salesian Institutions are using this human rights based approach

Giving Voice to the Voiceless: A rights-based approach to youth policies means: Empower young people to claim, exercise and defend their rights and fulfill their responsibilities through their active participation in society.

- Host and accompany all the speakers chosen by the Youth Ministry Department, to intervene on behalf of Salesians.





FVFNTS:


Participation in events in Brussels and other European cities is fundamental in order to make institutional contacts with several stakeholders that are of interest to Salesian Province or General Directorate.

Priority Migration and Refugees





As Don Bosco International, we are particularly interested in the inclusion of young people, through social and educational programmes, giving priority to those who find themselves in more difficult situations. We work for the implementation of effective policies and investment in social protection policies for children and youth.

- Intervention on European Parliament on EU projects.
- Support and coordination with Social Services strategy of the Salesian Congregation.








Priority Transition Education to Employment

Based upon the Salesian expertise on technical education and Oratorio tradition, we focus on the promotion of vocational training and nonformal education in order to increase the employability of young people. We believe in forging close links with businesses to promote apprenticeships, internships and quality jobs for young people.



HIGHLIGHTS:

- Active role in European Vocational and Skills week and European Alliance for Apprenticeships (EAfA) (several interventions in European Commission events).
- Joint initiatives with private sector (Pact for Youth and Apprentices in Motion).
- Support to the T-VET Coordinators and Project Manager Working Groups of the Salesian Congregation.
- Meaningful contribution to the Multiannual Financial Framework via Erasmus+ (interventions in the European Parliament).



Highlight Initiatives





DON BOSCO FEAST

Since 2017, the institutional feast of Don Bosco has been one of the milestones of Don Bosco International activities in Brussels. With the presence of one member of General Council: Fr. Fabio Attard in 2017, Fr. Stefano Martoglio in 2018 and Fr. Tadeusz Rozmus expected for 2019, commemorating our founder gives us the chance to meet with high level representatives of EU institutions and Church representatives in Brussels.



DOCUMENTARY MISIONES SALESIANAS

Upon a proposal of Misiones Salesianas (Madrid), in 2017 and 2018, we have organised institutional high level tours with Delegations of Salesians. In 2017, from Colombia with 2 young beneficiaries of our project and in 2018 from Sierra Leone, which will be repeated in 2019 due to high demand of EU institutions.

Reaching to High Level officials like High Representative Mogherini, projections in EU Parliament sessions, or working meetings with European Commissions desk officers have supported the work of the Salesians in the spot.

Prestige Leaflet

Don Bosco International edited in 2017 an institutional leaflet, in order to briefly explain the Salesian Congregation, to those meeting us for the first time. Using a very attractive design, this small folder gathers in 7 leaflets, 6 on the different pastoral sectors of the Congregation and 1 containing the map of the Salesian presence worldwide we have achieved a high level of visibility and a very easy way to share the educational work of Don Bosco Movement.









Church Relations

Don Bosco International, as EU office of the Salesians is one of the catholic organisations, present in Brussels. We tend to work in partnership with many other Catholic Inspired NGOs and hand in hand with the Commission of EU Bishops' Conferences (COMECE) which is a great supporter of our institutional action. As well in the diplomatic

sphere we are in regular contact with the Apostolic Nuncio to the European Union and increasingly with the Holy See Dicasteries in several of our priorities (migration, youth and social inclusion).

ADVOCACY SALESIAN PERSPECTIVE & CHILD AND YOUTH PARTICIPATION





Advocacy from a Salesian perspective: in this paper we have prepared some basic guidelines to provide an input in line with Don Bosco's charisma and the great experience built up in years, around the world, through the Preventive System,

focusing in changing the causes underlying the problem and not only mitigating the consequences of discriminatory policies. In this paper we gather the tradition, principles of action and core values of Salesian advocacy.

CHILD AND YOUTH PARTICIPATION

The aim of this policy document is to gather the many good practices that different Salesian organizations are developing to promote children and youth participation worldwide, by providing the rationale and fostering new orientations and horizons that can increase the access of young people to democracy and active citizenship.





POVERTY AND SOCIAL INCLUSION & SALESIAN APPROACH TO ACCOMPANIED MINORS

Approach to Unaccompanied Minors: Some of the major perils jeopardising the lives of young people in Don Bosco's time were the same many youths are facing today like migration. In this paper we present our Salesian mind-set in to our work with unaccompanied minors, regardless of whether they are refugees or migrants coming from difficult backgrounds. To help create uniformity of practice we briefly explain some fundamental principles of our work:

Poverty and Social Inclusion: As Salesians of Don Bosco and the whole Salesian Family, we are active in the fight against poverty, understood in the broader sense which goes beyond the mere economic meaning, and includes many other aspects. In this paper we share the type of work we do (defining broadly





or type of projects), how we do it (methodological general principles) in order to present that from practice in the field we advocate for the rights people facing poverty, especially children and youth.

ERASMUS AND MFF (EU BUDGET) COORDINATION

- YFJ and LLL Platform started a campaign Erasmusx10 to advocate for bigger investment in Erasmus+
- Together DBYN and DBI decided who should be present: as the coalition is also for schools and T-VET, DBI represents
- 3. DBI is member since October 2017 of this coalition and therefore has taken part in many hearing and debates about new Erasmus proposal

- 4. Whenever there is something on Youth Chapter at EU institutions, DBYN is invited both to contribute/reflect and also to take part if posible.
- Through Youth Integroup DBI presented DB approach to T-VET mobility but also in European Solidarity Corps
- 6. Several requests from MEPs to inputs on many new programmes: Rights & Values, ESC, Erasmus, ESF+, AMIF / AMF...







HUMAN RIGHTS ADVOCACY MEETING

- Started in 2014 after a meeting within DBYN seminar in Rome
- DBN took the lead of it, and gathered all its members once a year together with DBYN (1-2 representatives), FMAs, Cooperators, Past Pupils...
- 3. In 2016 DBI and DBN started preparing together this event
- 4. In 2016 DBI establish an Expert Group on Participation to coordinate better advocacy and make policy documents

- 5. In 2017, this group proposed the agenda of the meeting and DBI brought FRA representative for the training part. Some policy documents were drafted. More members/experts from DBI came
- 6. In 2018, we repeated the process with bigger success and with Holy See representative
- In 2019, we are planning visit to Holy See Dicasteries and 2 day meeting in February 2019 (10-11)


CATHOLIC INSPIRED NGO FORUM

- In February 2017 we were invited to a breakfast of Catholic inspired NGOs in COMECE to Foster coordination.
- 2. In December 2017 took place the third meeting in Rome, despite the invitation nor DBN or DBYN could participate.
- After the meeting DBI together with MIJARC advocated for having a 7th thematic group on Youth (and we succeded) (Why? SYNOD ON YOUTH)
- 4. Following the Rome meeting we started to foster a coordination between international Catholic Youth NGOs: first in DB Feast and second in the eve of YFJ COMEM

- Currently there is an advocacy cooperation with MFF advocacy and also with the thematic group on Youth
- 6. Next Forum is in December 2019
